Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2018-19 educational progress for the Wolverine Alternative Education Center. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. Since our students tend to be behind in credit accumulation, we have a heavy focus on credit accumulation and recovery along with skill development. Our students seldom stay with us for an entire school year. This makes data collection very difficult and unreliable. In order to capture more accurate data, we have started NWEA testing five times a year. With the data we are collecting the achievement gap for both males and females is closing. Because of our students' transient nature and leaving our school to go home at places all over the state, we have a hard time tracking students enrolling in colleges or trade schools.

State law requires that we also report additional information.

1. Students are court placed into our school district from all over the state of Michigan for various reasons including: adjudication, residential foster care, substance abuse treatment and others.
2. In April 2016 we went through an external review and were re-accredited as a school district and school for the next 5 years.
3. Camp 1 School works with mental health and diverse educational needs of up to 50 male students. Camp 2 School works with services both males and females with an emphasis on substance abuse. They also house a sex offender group as well as a residential foster care with emphasis on rehabilitation. They can educate up to 60 students on Camp 2. Vassar House School educates up to 48 females with a variety of circumstances ranging from adjudication to mental health. Clarence Fischer Center School houses shelter, Intensive Assessment Unit and a Mental Health Stabilization group. CFC school house up to 30 male students.
4. One to one technology was put into place for all students to do the online Edgenuity curriculum. All staff were trained how to facilitate Edgenuity to better serve our students. Edgenuity is currently aligned to state standards and benchmarks which can be found here <http://www.michigan.gov/mde/>. Our staff are developing a transition curriculum to

- Each year a Title 1D Performance Report, indicating student achievement scores on the NWEA, (Northwest Evaluation Association) is submitted to the MDE. (Michigan Department of Education) In this report, there is a summary of NWEA scores in the appendix disaggregated by Disability, Ethnicity and Gender. School improvement goals are established based on this data.

In addition, local assessments are administered as expected in our strategies and activities for NCA/Advanc-ED. These assessments are administered each marking period, reviewed and amended as necessary.
